You will also have the opportunity to attend a workshop with the District of Columbia Small and Local Business Development Agency and learn the requirements to enroll in the Certified Business

Enterprise (CBE) program to receive grants and contracts with the District government. Start-up businesses will be able to learn how to budget and save for a new business, and how to turn their talents in web-design, child care, hairstyling, and more, into a successful business.

In addition to these "how-to" workshops, a representative from the of the Small Business Administration will deliver a presentation on how the Affordable Care Act will affect your business, and will be available to answer your questions. You will also have the opportunity to learn more about the processing of the U.S. Citizenship and Immigration Services I-9 Forms and the confirming the eligibility of your employees through a workshop on the E-Verify program.
